4. That the school authority shall change/replace the Principal within 01 month and appoint Principal/HOS after following all due process and norms for the post of Principal/HOS (Compliance in this regard shall be submitted to DDE (SW-B-1) within 02 months.
5. That school shall get necessary permission to run Nursery classes from Competent Authority within 02 months.
6. That the school shall appoint and engage the adequate and eligible number of staff as per RRs at Sr. Secondary Level.
7. That the school shall appoint one more Special Educator within 02 months and submit the documents to the DDE, SW-B-1, within 02 months.
